# In search of the American Dream

Every American understands the meaning of the words 'the American Dream'. It has become an important part of American identity. No other country has a national dream. For hundreds of years people from far away have come to North America to find a better life. Today the Dream seems to mean that anything is possible if you want it badly enough. But there is not just one American Dream and its meaning has changed.

The Puritans and the first American Dream



The Puritans who came to New England in 1630 had a dream. In England they had been well-educated and rich and they

were members of the Anglican Church. However,
they did not agree with how the Church
practiced religion. Although they believed that
the world was not a good place, they knew
they could change it. So they left behind their
comfortable lives in England on a mission. For
these first Puritans change was starting a new life
and giving their children a better future. This was
the heart of the first American Dream.

They hoped the New World would become an example for the Old World. But many of the Puritans were not tolerant people. They believed God was only working for them and they expected people to join their church and respect its authority. In some places only those who were members of the new Church were allowed to vote. So in the beginning there were many fights with Indians and other settlers with different dreams about how to make their lives better.

## The promises of the American Revolution

By 1776 the new Americans had lived in the thirteen colonies for more than 150 years, but they did not have their own government. The British still took taxes<sup>2</sup> from them and had authority over them. In the American Revolution

the colonists fought for their freedom<sup>3</sup>. After they had won the war and become independent, the Founding Fathers of the United States wrote the Declaration of



Independence, which promised that 'all men are created equal<sup>4</sup>' and all men have the right to 'life, liberty<sup>5</sup> and the pursuit<sup>6</sup> of happiness.'

Like the Puritans these Americans hoped for a better life and their dream was freedom to live how they wanted. Although the new United States was the most equal society<sup>7</sup> in the world for white men, the rights<sup>8</sup> in the Declaration of Independence were only for some people. White men had the right to vote and make decisions and they had the freedom to own black slaves<sup>9</sup>. Black people, women and Indians were not part of the Dream.

#### **Dreaming of equality**

The first black slaves arrived in North America in the early 17<sup>th</sup> century. More than two hundred years later President Abraham Lincoln finally made them free, but he did not make blacks and whites equal. Until the 1950s African Americans and white Americans were segregated – blacks were not allowed to go to the same schools as white people; they could not sit together on buses; and they could not eat in the same restaurants. During the civil rights movement of the 1960s, Martin Luther King Jr. spoke for African-Americans when he said "I have a dream." His dream was that the American Dream in the Declaration of Independence would mean equality for people of *all* skin colors. One day all

Americans would have equality of opportunity<sup>10</sup>: Everybody would have the same chances whether they are black or white, rich or poor.

## Dream of the good life

Since the days of the Puritans the meaning of the American Dream has changed from freedom and equality to a more material happiness, but the Dream has always been about a better life. Many Americans believe that anybody who wants a better life can have it if they work hard enough and think positively. They love 'rags-toriches' stories about real people who have 'made it big'. For example, the 2006 film The Pursuit of *Happyness* tells the true story of Chris Gardner who was sometimes homeless and even in jail before he became one of the richest and most successful African-Americans on Wall Street. When he was finally given a chance, he worked without pay for many months and had to show that he was good enough for the job.

After World War II Americans typically worked
hard so they could become homeowners in the
suburbs and buy cars or a TV. Soon, however,
they began to watch as movie stars in sunny
California enjoyed their fame and luxury. Stars
have bought bigger and bigger dream homes
with swimming pools and huge backyards. They
own expensive cars, planes and vacation homes.
They seem to have an easier life, and more and
more 'normal' Americans want that life. Like the



people who went to California to find gold in the 19th century, many Americans today hope to 'strike it rich' in the lottery or gambling<sup>11</sup> in Las Vegas. Teenagers and adults also try to become rich and famous in reality TV shows like *American Idol* or *Big Brother*. It's no longer necessarily about skill or hard work.

But is the American Dream still possible? In a weak American economy<sup>12</sup> many Americans are losing jobs and homes and they have less money to do the things that they enjoy. Large numbers of people are afraid of losing everything and they 125 believe that their lives and their children's future will not improve even if they work harder. Once upon a time America was 'the Promised Land' for people all over the world. But is the American Dream now available only for the lucky few?
